I met with Mr. Sullivant one other time when he was being admitted to Azalea Gardens which is now Elmcroft. I did his admission orders. His diagnoses listed at that time were cognitive impairment that is mild, hypertension, BPH, and osteoarthritis. He cares for himself. He gives himself his own medications. He still drives. He is planning to get a new pickup truck. He was wanting a handicap sticker today which he definitely qualifies for.

Dr. Hobbs and I met with him together and separately. He answers all questions appropriately. He has not had any car accidents or anything like that. A Mini-Mental Status was updated, and he scored a 29 out of the total of 30 today which is excellent.

CURRENT MEDICATIONS:

Amlodipine 2. 5 mg daily, Aspirin 81 mg q day, Chlorthalidone 25 mg q day and Quinapril 40 mg q day.

- A: 1. Records are going to be faxed to his attorney. Mr. Sullivant seems to be completely competent to manage his own business affairs. He is a bit hard of hearing which makes communicating difficult but once he understands questions, he answers them appropriately. The mini-mental status verifies that he has no cognitive ability with basics.
- P: 1. Records will be faxed at his request and a release has been signed. I did provide him with a handicap tag application today.
- 2. He will return to our clinic as needed. He does not have a scheduled follow up appointment at this time but needs one.
